

AFFORDABLE APARTMENTS FOR RENT IN THE LOWER EAST SIDE AND CHINATOWN

Stanton Norfolk Inc. is pleased to announce that applications are now being accepted for a limited number of available re-rental apartments within a number of affordable housing developments in the Lower East Side and Chinatown sections of Manhattan. These affordable housing developments received financing through one or more grant and/or loan programs from New York City Housing Preservation and Development (HPD). Rent levels and income requirements may vary amongst different buildings, but the following chart provides general guidelines and ranges:

When is the Deadline?

Applications are being accepted until available apartments are fully rented. A waiting list will be created.

What Happens After You Submit an Application?

Applications will be processed in chronological order, based on the date and time that they are received. If you appear to qualify based on the information provided on your application, you will be invited to an appointment of eligibility to continue the process of determining your eligibility. You will be asked to bring documents that verify your household size, identity of members of your household, and your household income.

Once vacancies are filled, remaining qualifying applicants will be placed on the waiting list to be processed for future vacancies.
